
CAAR Broker Outreach Scheduled for June 14th



SeeHouses.com Traffic Down 9.6 Percent in March

During the month of March 2013 there were 25,283 visitors to www.SeeHouses.com, reflecting a decrease of 9.6 percent from the same period in 2012 when there were 27,982 visitors.
